<b>Total Permit Fee</b>		
Greater of Section A or B (not both)		Electrical Inspection (REI) with a minimum fee expires in 6 months. Permits over the minimum fee and up to \$1,000 expire in 12 months. The applicant must have the work completed within that period or submit another REI that includes the inspection fee for the uncompleted work. Inspection fees do not carry over from one REI to another.

## **“OWNER” ELECTRICAL PERMIT DISCLAIMER**

I understand that it is illegal for anyone other than the homeowner who has signed the electrical permit for or a licensed electrical contractor to do electrical wiring in Minnesota. “Anyone” includes family members and/or electricians that are not licensed contractors.

The term “homeowner” refers to the person whom the property is deeded to and that this person is living at the address of the permit on file. This does not include duplexes, condominiums, or any other multi-family or rental occupancy, commercial or industrial properties.

The homeowner doing the work shall prove to the inspector’s satisfaction, that he or she is capable of performing the work to be done.
